- f) in the case of an academic paper in which several works, including those already published in coordination with the supervisors, are incorporated with the participation of the doctoral student: A **detailed synopsis, an appraisal of the individual contribution made**, and the contributions of the other authors to the respective publications as well as **a sworn statement** regarding my own contribution in accordance with § 10 (2),
- g) in the case of **teamwork**: a report jointly written by the persons involved regarding the collaboration on the doctoral thesis, indication of the individual authorship of the respective parts of the doctoral thesis, furthermore indication of names, academic titles, addresses of the persons involved in the group work as well as information on the question as to whether any persons and – if applicable – which persons have already applied for a doctoral procedure, or completed such a procedure, and have used parts of the submitted work in the process, furthermore details of names, academic degrees, addresses of the persons involved in the group work as well as information on which of the persons have already applied for or completed a doctoral project, using parts of the submitted paper,
- h) I further declare in accordance with § 8 (1)h) of the doctoral degree regulations
1. that I am aware of the current doctoral degree regulations of the Faculty of Mathematics,
